Pre-Matric, Post-Matric and Merit-cum-Means based Scholarship Schemes are being implemented as Central Sector Scheme, with 100% Central funding for the year 2018-19. Under these schemes, the scholarships are awarded to the economically weaker and meritorious students from six notified minority communities viz. Muslim, Christian, Sikh, Buddhist, Zoroastrian (Parsis) and Jain, pursuing studies in India in a Government or Private Universities/Institutes/ colleges/schools.

- 2. The Central Government has decided to open the National Scholarship Portal (NSP) on 23rd July, 2018 for the three Scholarship Schemes for 2018-19. The last date for receipt of online applications will be 30th September, 2018. As such, it is incumbent upon this Ministry to initiate the process of issue of advertisement inviting online applications, by the State Government/UT Administrations, which shall be implemented as per existing guidelines. At the National level, Ministry of Minority Affairs will be issuing advertisement.

The State-wise/Community-wise physical allocation (as per Census 2011) for Fresh Scholarship in respect of three Scholarship Schemes for the financial year 2018-19 is 30 lakh, 5 lakh and 60,000 for fresh scholarships (Copy enclosed).
